

The contract and budget review process will occur in parallel with IRB review. Below is an outline of our standard Protocol Review process.

Start-up Fee (\$1,500) and Subsidy Recapture Fee (\$1,250): One-time, non-refundable fee, includes variable and non-variable fees These fees cover the costs associated with the different processes involved in preparing a study to open, such as:

- Feasibility Review
- Site visits (i.e., Site Selection Visits, Pre-selection Visits, Site initiation visits, etc.)
- Preparation of the regulatory documents (i.e., Form 1572, FDF, DOA, etc.)
- Preparation and entry into the Clinical Trials Management System (CTMS)
- Assessment of the study budget and contract negotiation
- Study account set-up
- Clincard set-up

These fees do not include core research services such as Institutional Review Board (IRB), Regulatory Core, Investigational Drug Services, Clinical Operations Core, Bionutrition Core, and the Engagement Core.



CTO Coordinator Pool (\$87/hr): The Research Coordinator Core provides a wide range of research coordination and management services at an hourly rate. The staff includes licensed nurse research coordinators and experienced research coordinators. We assist with recruitment, screening, consenting, and overall conduct of study visits. This includes facilitating focus groups, interviews, questionnaires, lab processing, and more. Our flexible staffing model allows researchers to increase or decrease usage as needed. Researchers only pay for actual hours that staff spend directly supporting their projects.

CTMS Maintenance Fee (\$495): This fee covers critical functions that enable efficient study management, compliance with regulatory standards, and the protection of sensitive data. It supports system updates and customizations relevant to the study.

Protocol Amendment Fee (\$500): Amendments may or may not be required in the course of the study. However, in the event they are required or requested by the sponsor, these are our site's standard fees. Amendments include, but are not limited to modifications to research which require board review, such as protocol amendments, revised protocols, updates to consent forms, and new recruitment or retention materials, which covers the cost of reviewing the materials, any updates to the CTMS system and associated calendar and the related administrative responsibilities of preparing review documents and updating the investigator file.

Record Retention Fee (\$1,500): Accounting for a minimal of 7 years of study document retention at Iron Mountain and/or other MSM-contracted facility.

Study Closeout Fee (\$1,500): Accounting for an average of 20 hours of study team and research administrative effort to prepare, review, and participate in study close-out activities.

Regulatory Core

The Regulatory Core works in partnership with study team members to successfully navigate the clinical research regulatory landscape throughout the lifecycle of a study.

Investigational Drug Services

The Investigational Drug Service (IDS) of the Morehouse School of Medicine is responsible for the consistent and centralized management of pharmaceutical/investigational drug protocols used in human subject research, at all sites under the Clinical Research Center (CRC). The Investigational Drug Service serves as the management unit for the storage, dispensing and disposal of study medication for many clinical trials. It ensures standardization of procedures within each protocol, and further protects human subjects who participate in research protocols, through improved drug safety and accountability measures.

Description of Services

Study Initiation:

- Fees are charged for the work of setting up a study and of performing necessary staff training which include:
 - Review protocol and prepare budget
 - Drug Build and Reviews
 - Orderset reviews
 - Meet with sponsor or investigator
 - o Receive and process initial shipment of study drug
 - In-service staff (as needed)
 - Prepare study fact sheet and drug information fact sheet for pharmacy staff and nursing staff (as needed)

Study Maintenance:



- Maintain appropriate inventory storage, study records
- Update ordersets/review based on amendments
- Order and receive inventory
- Process expired inventory and patient returns
- Store patient returns
- Periodic study billing

Study Closeout:

- Process study records to archive
- Meet with participant for closeout visit
- Final billing
 - o Additional cost: Process study drug for Return to sponsor/ destroy on-site

Clinical Operations Core

The Clinical Operations Core consists of experienced, skilled nurses and laboratory technicians who demonstrate a high level of clinical expertise, critical thinking, and complex decision-making skills. They are responsible for protecting the study participant and administering clinical services according to IRB-approved study protocols.

Nursing Level 1: Minimal intensity: vital signs, weight, height, pulse oximetry, 6-minute walk test, specimen collection- 1 timepoint

Nursing Level 2: Minor intensity: 12-lead ECG. IV Placement, all medication administration, post administration monitoring <1 hour, specimen collection- multiple time points <3 hours between collection. Vision testing.



Nursing Level 3: Moderate intensity: IV infusion, post administration monitoring >1 hour

Nursing Level 4: Moderate intensity: Glucose tolerance test, testing requiring the skills of an Advanced Practice Provider, complex sample processing

Nursing Level 5: High intensity: Multiple IV infusions, biopsy (fat, muscle), procedures requiring multiple nurses

The Bionutrition Core is comprised of a Metabolic Research Kitchen and Body Composition Lab and provides the following services:
